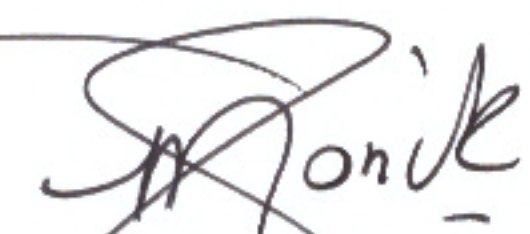
NOTICE OF INTENTION TO NOT OPPOSE
